As we begin the new academic year, it is exciting to think about what the next few months will bring. Many of the NTWCA members are involved in various conferences and research projects. Several members also have new duties in their writing centers and are busier than ever.

Even with our busy schedules, it's important to take some time to think about the impact all of us have on developing writers. At the forefront of this effort are our consultants. In particular, our peer tutors are such an important part of what makes our writing centers successful. I am always in awe of the energy and expertise our peer tutors bring to their writing center work. In the past few weeks, I've been privy to listen to several difficult tutorials. Our tutors handled these situations with maturity and grace. On more than one occasion, it was clear that the students who came for help not only needed writing help but also someone to understand their individual challenges. One student, for instance, was angry at having failed an important writing test, while another was completely stressed out by her composition class and life in general. Yet another is far from home and doesn't understand much English; she is homesick and worried about making progress in her classes. In each case, the students needed writing help, but they needed something more. And, in each case, our tutors showed compassion, understanding, and empathy. By doing this, they were able to turn what could have been unsuccessful tutorial sessions into memorable discussions about life and writing.

The NTWCA fall conference is a time to celebrate our peer tutors and all of the consultants who make our writing centers what they are. I know we are all grateful for their dedication, their commitment to student writers, and their pursuit of excellence.

One way our organization acknowledges the good work the tutors do is by hosting a fall conference which focuses on situations of particular interest to our consultants. Our kevnote speaker this fall is Dr. Lou Thompson from Texas Woman's University. Dr. Thompson is an expert in disabilities rhetoric and will share her presentation "'One of Us:' Situating Disability in the Writing Center." This presentation is most valuable as our writing centers continue to offer services to a diverse student population. In addition, the staff from the William L. Adams Center for Writing will contribute a short comedy routine titled "Comedy in the Writing Center."



About Our Keynote Speaker

Dr. Lou Thompson is a Professor of English at Texas Woman's University. She has been a member of the TWU faculty since 1998. During her time there she has served as the Interim Director of the First-Year Writing Program and the Write Site (2006-07) and the Interim Department Chair (Spring 2005).

Dr. Thompson teaches graduate level courses at Texas Woman's University that range in subject matter from the Romantic Poets, to the History of Rhetoric, Visual Rhetoric, and the Rhetoric of Disability. In her time at the University, she has either chaired or served on 21 doctoral dissertation committees, several of which dealt with research in the fields of composition, writing center theory, and/or disability theory.

Just as is the case with her university service, Dr. Thompson's professional presentations and publications cover a wide range. She has presented and published in the fields of Composition Studies, Film, Disabilities Studies, and Literary Criticism. Her publications include *The Resourceful Reader* and *Rhetorical Contexts*.



Dr. Thompson received her B.A. from North Texas State University, her M.A. from Louisiana State University, and her Ph.D. from Texas Christian University.

A Special Announcement

Under the umbrella of NCTE and CCCC, Mike Matthews, Dean of Humanities at TCC Northwest Campus and long time member of the NTWCA, is serving on a committee of the Two-Year College English Association to revise the "Guideline for the Academic Preparation of English Faculty at Two-Year Colleges." He is soliciting ideas for the revision of this document and any updates for the bibliography. A copy of the document can be found at

Note that writing centers are included under recent trends in item 2.

Here is the charge:

- 1. Review the 2004 position statement, Guidelines for the Academic Preparation of English Faculty at Two-Year Colleges, to determine the currency of the existing document and to establish the areas that require revision.
- 2. Engage in research to incorporate recent trends in the field, e.g. First Year College, multiple literacies, multiple deliveries, international students, service learning, writing centers, and other movements in education. (I would add the trend of high schools placed at college campus locations called "Middle College" and "Early College" depending on the programs housed there, whose students take college courses.)
- 3. Consider the relationship of adjunct faculty and the English Department of two-year institutions.
- 4. Engage in a thorough review of the existing Bibliography and recommend revisions.
- 5. Submit a preliminary written report of the work accomplished and recommended revisions according to the committee time line.
- 6. Submit a draft of the revised document according to the committee time line.
- 7. Submit a final draft of the revised document according to the committee time line.

Alice Newsome, assistant professor of English, has a B.S. in Counseling and English from Texas A&M University-Commerce and holds a M.Ed. from Tarleton State University, with specialized courses taken post-Master's in rhetoric, composition, and literature. She co-directs the Writing Center and the Basic Writing Program at Tarleton, and she teaches basic writing, composition courses, and literature. In recent years, she has presented at NTWCA, CCTE, and SCWCA conferences. Her research interests include the examination of the psychology of the basic writer and the application of writing center theory to the composition classroom (individualized instruction in the classroom). For a number of years, she has helped select and train graduate assistants who work with the basic writers and in the writing center.

Ben Sword is currently serving as the Vice President of the NTWCA. Before serving in the capacity of Vice President of the NTWCA, Ben held the office of Treasurer for 2 years. He is an instructor at Tarleton State University and Co-Director of the Writing Center, along with Alice Newsome.

Angela Pettit is a faculty member at the TCC Northeast Campus.

Elizabeth Parrish holds a B.A. in English from the University of North Texas. She spent many years working in fields unrelated to education until she accepted a short term position teaching English in China. Returning after six months abroad, her renewed interests in the teaching field lead her to pursue a teaching certificate. She accepted the position of Instructional Associate at the Northeast campus of Tarrant County College where she directs the Writing Center. Elizabeth recently completed the notable TCC Leadership program. She is coordinating the addition of a workshop and lecture series to her Writing Center.

Cynthia Shearer holds an M.A. in English from the University of Mississippi and is the author of two works of fiction, *The Wonder Book of the Air* (Pantheon /Vintage 1996) and *The Celestial Jukebox* (Shoemaker &Hoard/Avalon, 2005). Her work has appeared in such publications as *Tri-Quarterly*, *The Missouri Review*, *The Quarterly*, *The Oxford American*, *The Hungry Mind Review* (now *Ruminator*), and *Speakeasy*. Awards for her short fiction include Honorable Mention in Best American Short Stories, and inclusion in various anthologies such as *Beyond O'Connor* (University of Georgia Press, 2003) and *The Best of the Oxford American*. Her first novel won the 1996 prize for fiction from the Mississippi Institute of Arts and Letters. She was the recipient of a fiction fellowship from the National Endowment for the Arts in 2000. In October of 2005, her *Speakeasy* essay, based on her six years of experience as the curator of the William Faulkner home Rowan Oak, appeared in the thirtieth anniversary issue of the *Pushcart Prize Anthology*.

Cheryl Carithers received her M.A. in English with a specialization in rhetoric and composition from Tarleton in 1999. In addition to teaching, Ms. Carithers has worked as a professional editor. Her research interests include the history of composition, rhetoric and pop culture, literature, and writing center theory. She is currently an assistant director in the William L. Adams Center for Writing and an instructor in the TCU English Department.

CONSTITUTION OF THE NORTH TEXAS WRITING CENTERS ASSOCIATION (REVISED SPRING 2007)

- I. The North Texas Writing Centers Association serves writing centers of the region as a clearinghouse for exchanging information, as a forum for discussing important writing center issues, and as a means of promoting the professional status of writing center personnel.
- II. Membership in the NTWCA includes directors and staff of writing centers and persons interested in writing centers. Membership can be multiple-campus institutions (\$25 per campus), single-campus institutions (\$50), or individual (\$10). Institutional memberships include writing center staff and tutors at the institution.
- III. NTWCA assesses dues annually at the fall meeting. Memberships run from September through August. Monies collected are used for communication, publication, and conference expenses.
- IV. The right to vote and to hold office extends to all individual and institutional members.
- V. The following elected officers serve a two-year term and may be elected for multiple, two-year terms:
 - a. President: The president chairs all meetings, facilitates the operations of the association, and serves as co-chair of the Membership Committee.
 - b. Vice-President: The vice-president functions as program chair and assumes the duties of the president in the president's absence.
 - c. Newsletter Editor: The newsletter editor gathers information, edits articles, publishes the newsletter, and handles mailings.
 - d. Secretary: The secretary takes minutes at meetings and reports at executive board meetings and conferences.
 - e. Treasurer: The treasurer collects dues, records memberships, reports finances and memberships at meetings, and serves as co-chair of the Membership Committee.
 - f. Immediate Past President: The immediate past president serves as an advisor and assists other officers in discharging their duties.
- VI. The president appoints the following officers for two-year terms:
 - a. Web Spinner: The web spinner maintains the NTWCA website page.
 - b. Archivist: The archivist serves as custodian of the organization's records.
- VII. The Membership Committee is co- chaired by the president and treasurer and consists of three volunteers from the organization membership. The membership committee promotes involvement by serving as the NTWCA's outreach liaisons, contacting potential members at colleges, universities, and secondary schools in the area, and conducting an annual membership drive.
- VIII. The Executive Board, consisting of the six elected officers and two appointees, meets at least twice per calendar year to plan meetings and conferences. When officers and

- appointees are selected at the spring meeting, they immediately assume their duties and plan the schedule of events for the following year.
- IX. If an officer resigns, the Executive Board will appoint an interim officer to serve out the officer's term. If the resigning officer's term has more than one year remaining, the association will elect a new officer at the next regular meeting to serve out the remainder of the term.
- X. The NTWCA sponsors two conferences per calendar year.
- XI. This constitution may be amended or replaced by a majority vote of the executive board and membership at any business meeting.
